

## Appointment of Non-Executive Director

**2 AUGUST 2021:** 3D Metalforge (ASX: 3MF) (“3D Metalforge” or the “Company”), is pleased to announce the appointment of Mr David Buckley as an Independent Non-Executive Director of the Company, effective on 1 August 2021. He was previously an Advisor to the Company.

Mr Buckley brings over 30 years of global leadership experience and finance expertise in public and private companies. He holds a number of non-executive board positions and is currently Chairman of Royal Bank of Canada (Europe) Ltd., Redwood Bank, a fast growing UK “Challenger” bank launched in 2017, and of Archax Ltd, a Fintech company formed in 2018. Archax is the first ever Digital Securities Exchange to be regulated by the UK FCA. It is targeted at Institutional clients and has FCA brokerage, custody and cryptoasset permissions.

He previously held the position of European CFO for Morgan Stanley, Chief Executive of Morgan Stanley Bank International and prior to then, he was International Treasurer and European Head of the Global Banking Group for Goldman Sachs.

Mr Buckley also covered the roles of Non-Executive Director and Chair of the Audit Committee for CIBC World Markets plc, and lead Independent Non-Executive Director for Fullerton Health in Singapore.

“We are delighted to welcome David to the Board,” said 3D Metalforge Managing Director, Matthew Waterhouse. “It’s a testament to our business that we were able to attract such a highly-credentialed individual to help underpin our long-term growth. David’s wealth of relevant leadership and finance experience guiding companies through growth will be a valuable addition as we advance our strategy.”

Mr Buckley will be issued with 500,000 unlisted option exercisable \$0.25 per option, expiring 3 years from the date of issue, under ASX Listing Rule 10.12 exception 12.
